- ★ Crosses sectors (e.g., child care, Head Start, early intervention and special education, and public schools)
- ★ Serves professionals preparing to and working with and on behalf of young children and their families (i.e., direct and non-direct service staff)


#### Policy Blueprint: Planning Guide

- ★Step 1. Gather and Describe: What are your current state workforce system policies?
- ★Step 2. Analyze: Do the policies apply or meet the policy-making principles?
- **★Step 3. Determine: What are your goals?**
- **★Step 4. Discuss and Consider: What are your opportunities?**
- ★Step 5. Plan: What are your priorities?

★ Minimum percentage of states\* with one or more early childhood workforce development policies in statute, regulation, or executive order






### NPDCI Definition of Professional Development


★ "Professional development is facilitated teaching and learning experiences that are transactional and designed to support the acquisition of professional knowledge, skills, and dispositions as well as the application of this knowledge in practice.....



### **Conceptual Framework for PD**









A model for matching training approach to desired training outcomes and complexity of application. (Adapted from Harris [1980].)<sup>4</sup>


